Dear LiiRA participants,

Hope you are all enjoying the spring weather. We are excited to share that our first official LiiRA paper will be published soon in the Journal of the American Heart Association. In this study, we found that while most of your stress tests were normal, we are seeing evidence that inflammation may be affecting the function of the small blood vessels in the heart of individuals with RA more so than individuals without RA.

Since there are limited data on the long term impact of inflammation in these small vessels, we are conducting a smaller LiiRA extension study. In this study, we will be inviting some of you back for a repeat stress test and another test that allows us to take a closer look at the amount of cholesterol plaques in your coronary arteries. Both tests are routine clinical tests at BWH used to screen patients for heart disease.

Are you a 'non-responder' to your rheumatoid arthritis therapy?

If you participated in LiiRA, you've all tried certolizumab which belongs to a group of drugs called biologics. Have you gone on to try other RA therapies that ultimately did not work for you? If yes, you may be eligible for a new study, People-Powered Medicine (PPM): Rheumatoid Arthritis Non-responders to Treatments (RANT).

RANT is a study that you can join online, on your time. We are doing this study in collaboration with the Harvard Medical School Department of Biomedical Informatics.

RANT Eligibility Criteria

- 18 years of age or older to participate.
- Tried 3 RA biologic or targeted synthetic therapies, e.g. certolizumab, etanercept, tofacitinib
